Dues shall be \$20 per year and will entitle the member to all discounts available to the team plus voting privileges in general elections held by the team.

We intend to be totally supportive of our namesake local bike shop and will take advantage of the great discounts afforded by ie Bikes, Inc, and will purchase bikes, gear, clothing, parts, accessories, and repairs from that shop whenever possible.

Members shall conduct themselves at all times in a manner to reflect favorably on the team and on the sponsors. Particularly when wearing team designed clothing, we must keep in mind that we are representing our sponsors and act accordingly. We should refrain from the use of foul language, demonstrating disrespect for our sponsors and / or their products, public intoxication, rowdiness, or any other acts which would represent our team and / or our sponsors in a detrimental manner. Members shall be subject to expulsion in the event of flagrant violation of these bylaws, but only after a unanimous vote of the Executive Committee.
